CITY OF WYOMING PARK USAGE FEES

Pavilions

For reserving pavilions for gatherings. There is no charge for using pavilions without a reservation. A refundable damage deposit of \$50 is required.

Residents: No Charge

Non Residents: \$25 for up to 4 hours

Sports Fields

For reserving sports fields for organizations. There is no charge for pick up games, when the field is available and not otherwise reserved. The fee for soccer, football, softball and baseball fields will be **\$10 for each field up to 2 hours, and \$5 for each additional hour or any part of that additional hour or hours for each field.** If required, teams are responsible to chalk the fields for the boundaries and other lines. The soccer fields on the north side of Goodview Park are small fields which can only be reserved for soccer participants that are 14 or younger.

Fees are required for reserved practices as well as games.

***Tournament Play: \$150 for field usage Per Day, Per Field.** This would be for all day tournaments. City staff that already is scheduling teams for the various fields will also collect the fees. The fees are due prior to the reservation being confirmed.

*Fees collected will simply be an estimate of usage.

Fees are intended to pay for park maintenance as well as park improvements.

Fees and rules are subject to change without notice.
