The Planning Commission reviews, holds public hearings, and makes recommendations to the City Council on all applications for plats, zoning amendments, variances, site plan reviews, and conditional use permits. The City Council makes the final decision on whether to grant or deny all applications. The City Council meets at 7:00 p.m. on the 1st and 3rd *Tuesday of each month.

***Applications** that include improvements (streets, stormwater ponding, etc.) will not be heard until the city engineer has completed the review of the improvements.
